

## **IMPORTANCE AND IMPACT OF PALLIATIVE CARE CLERKSHIP ON MEDICAL STUDENTS EXPERIENCE**


### INTRODUCTION

The palliative care (PC) approach is generally considered only in selected stages of severe diseases and is still neglected in general medical competence. In modern hyper-specialized medicine, the privileged approach addresses the disease, while symptoms, psychological needs, and related social problems are rarely addressed other than with axillary drugs.

In the last four years, 18 medical students at our university attended a clerkship in oncology PC outpatient. They were randomly assigned and accepted to participate in a survey investigating interest, knowledge acquired, and usefulness of PC clerkship on their education.

RESULTS

Most students showed increased interest in PC, self-perceived, and actual knowledge of oncology and PC after their clerkship. All the students evaluated the training as useful in their education with a Likert scale score of 4 and 5. In the qualitative section of the survey, students expressed appreciation for PC's holistic approach, got excited for the ability to listen actively and communicate clearly and with empathy, and for the importance of the quality of life each patient defines. Students affirmed they would use this approach in their future careers.

**METHODS** 

We administered a quantitative/qualitative survey to the students on the first day and after the end of the clerkship, investigating previous experience in oncology and/or PC, interest in oncology and/or PC, self-perceived and actual knowledge in oncology and PC, and usefulness of the training, evaluated with a Likert scale 1-5. The survey ended with open questions assessed using qualitative methods.
